Automated decision-making

GROUP7 does not make decisions based on automated processes regarding matters that may have considerable consequences for people.

How long we store personal data

GROUP7 stores your personal data for as long as necessary to achieve the goals for which the data were gathered.

Sharing your personal data with third parties

GROUP7 does not sell your data to third parties and will only share with them where this is necessary for the performance of our agreement with you or to comply with a legal obligation. We conclude a data processing agreement with companies that process your data on our behalf in order to ensure an equal level of security and confidentiality for your data. GROUP7 maintains responsibility for this processing.



Cookies and similar technology that we use

GROUP7 only uses technical and functional cookies, as well as analytic cookies that do not compromise your privacy. A cookie is a small text file that is saved on your computer, tablet or smartphone upon your first visit to a website. The cookies that we use are necessary for the technical functioning of the website and your ease of use. They ensure that the website works properly and remember your preferred settings, for example. This also enables us to optimise our website. You can opt out of cookies by changing the settings of your internet browser so that it no longer saves cookies. You can also delete all information that has previously been saved in your browser settings.

Access, change or delete data

You have the right to access, rectify or delete your personal data. You can do this yourself via the newsletter. You also have the right to revoke any consent to data processing or to object to the processing of your personal data by our company and you have the right to data portability. This means that you can submit a request to us to send you – or another organisation specified by you – a digital file of the personal data that we hold of you. If you want to make use of your right to objection and/or right to data portability or you have any questions/comments regarding data processing, please send a specific request to info@group7.eu.

To verify that the request has been made by you, we ask that you send a copy of your proof of identity with the request. Please block out your passport photo, the MRZ (machine readable zone, i.e. the strip of numbers along the bottom of the passport) and passport number in this copy, as well as your citizen service number (Netherlands: BSN) where applicable. This is to protect your privacy. GROUP7 will respond to your request as soon as possible, no later than within four weeks. GROUP7 also wishes to point out that you may submit a complaint to the national supervisory authority, the Dutch Data Protection Authority.
